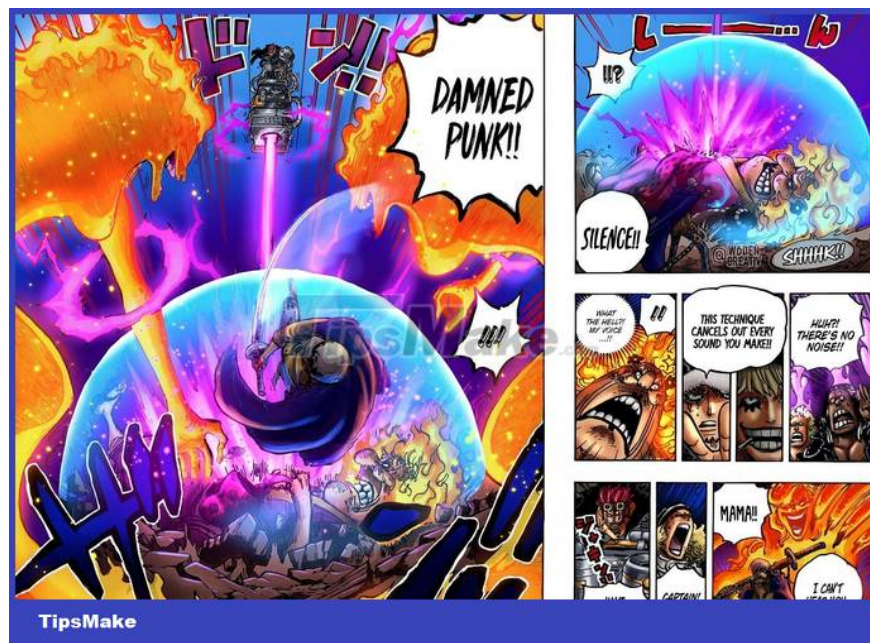


One Piece: The fate of Yonko Big Mom after the Wano arc

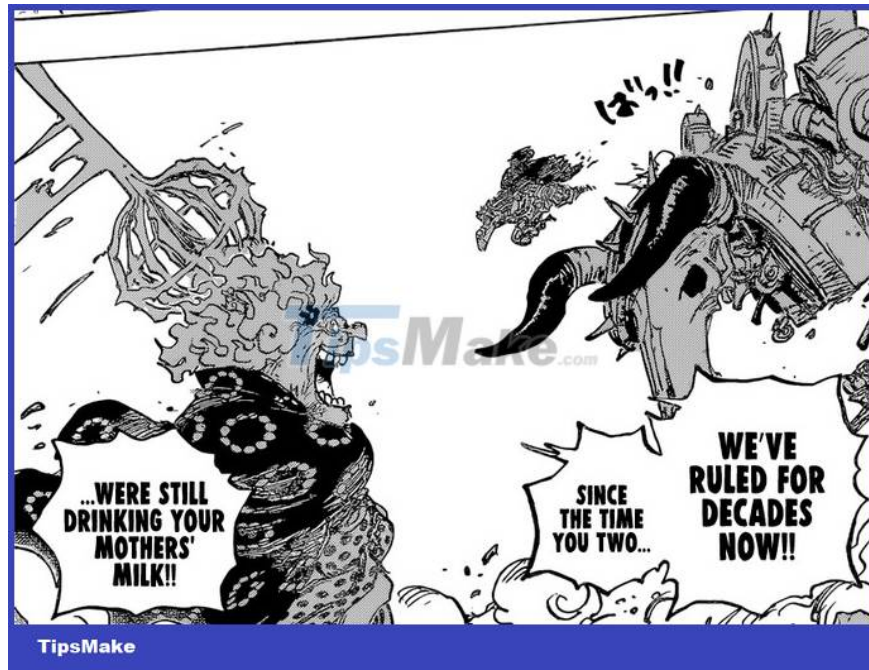
After the Wano arc of One Piece is coming to an end, besides Kaido, what will be the fate of the other Yonko, Big Mom?

After the past chapters, Oda has successfully completed raising the power of those who are capable of taking the position of Luffy's pirate king in the future. Not only that, we also know more about the ability and true strength

of the Yonko. Despite being so powerful, but after Luffy owns Gear 5, Big Mom will have to be very cautious when there is a high possibility that these two characters will have a fight with each other, especially in the land of Elbaf.
